The 2024 annual event of the Network of Centers (NoC), convened in partnership with the Digital Asia Hub Thailand (DAH.th), aims to address the pivotal moment our societies face due to the rapid digital transformation and proliferation of AI. This year's event moves beyond routine discussions, focusing on substantial issues that shape our current global landscape in a volatile world.

An interdisciplinary examination of the "state of the world," with a focus on the intersections of technology and society, sets the stage for mutual learning and knowledge exchange among NoC participants as well as invited special guests. The overarching goal is to accelerate the implementation of the NoC roadmap, emphasizing impact and translating research into practice while addressing broader themes crucial to our collective future.

The event will feature a variety of formats, including sparks and keynotes, panel discussions, interactive workshops, and green space sessions. Attendees will explore topics such as the societal implications of emerging technologies, digital governance, the ethical dimensions of digital transformation, and the roles and responsibilities of academia.

Additionally, the event will facilitate knowledge exchange between NoC participants and the leadership, staff, and fellows of Thailand's first AI Governance Center, hosted by the Electronic Transactions Development Agency (ETDA) and incubated by DAH.th.

To maximize global reach and inclusivity, the event will combine in-person and virtual participation. Active engagement will be encouraged through interactive questions and answers (Q&A) sessions, polls, and social media activities.
